



ILLINOIS WELCOMES NASC CONFERENCE

Forest View High School, a large and impressive senior high serving the Chicago suburb of Arlington Heights, Ill., stands ready to greet delegates to the 1972 NASC National Conference, June 25-29. "Youth in Action," the theme of this year's "action" conference, went into effect there many months ago as students and staff began preparations for the Assocation's thirty-sixth annual meeting.

Planning sessions at Washington headquarters have also brought results. Promised as the keynote speaker for the First General Session is one of the top

national figures.

The 18-year-old vote and its implications will be the topic of the Second General Session, which will feature a student panel chaired by NASC Advisory Committee Chairman Keith Franz and including Lawrence Hamm, controversial 19-year-old voting member of the Newark (N.J.) Board of Education; Chic Chalmers, 1967 NASC president and a former aide to Senator Birch Bayh; Carroll Ladt, executive director, Youth Citizenship Fund, and Michael Simmons,

18-year-old draft board member from Marysville, Pa.

"Experiment in Communication with Light and Sound," a communication seminar presented by the Illinois Bell Telephone Company, will be the main attraction of the Third General Session.

In addition to traditional discussion sessions, students will have an opportunity to explore current problems in depth with experts in the field during newly created conference seminars. NASSP Director of Publications and Editorial Services Thomas Koerner will lead the seminar entitled "Student Newspaper: Watchdog or Patsy?"; NASSP Assistant for Legal and Legislative Services Thomas George will develop ideas presented in his monthly Highlights column "Students and the Law" in a seminar of the same title. Two film seminars, each featuring two documentary films on youth related issues, "A Way to Go," and "Is Anybody Listening?", an action report of the White House Conference on Youth, will focus on group discussion following the viewing of the films.

Highlighting delegates' trip to the Chicago area will be a full-day sightseeing tour of the city for students and those advisers wishing to participate. Following a tour of the Science and Industry Museum, delegates will have lunch at famous McCormick Place, where they will be officially welcomed by Mayor Richard Daley.

Other social and recreational activities for students include an opening night mixer and get-acquainted party, a picnic, impromptu sporting events, and an endof-conference banquet and dance.

Advisers will be housed at the Arlington Park Towers Hotel during their conference stay. A special feature for advisers at this year's conference will be the series of meetings, social activities, and workshops under the leadership of Earl Reum, well-known student council spokesman and director of student activities for the Denver (Colo.) secondary schools. Also participating in special advisers' sessions will be Thomas Koerner and Thomas George.


WILLIAMSBURG IS UNFORGETTABLE EXPERIENCE

A first place awarded to York Community for their entry in the category for Scrapbook; and


A first place awarded to Hinsdale South for their entry in the category for Issues.



ORGANIZATION: The basic organization of the workshop will be the "Council Plan." Delegates will be divided into councils of approximately 25 members. Each of these councils becomes a student council in a hypothetical school. These hypothetical schools and councils will be typical situations in Illinois. Each council will be under the direction of experienced adults and junior counselors. The daily schedule will consist of general meetings, council meetings, assignments, consultant lectures and special sessions. Dancing, swimming, and other types of fun-filled recreation are planned for evening entertainment. The development of leadership at either work or play is the aim.

WHO MAY ATTEND: Students from schools who are members of the IASC are eligible to attend. Advisors may attend if

they wish, but their attendance will not be a requirement. The school or the parents will be responsible for the student's transportation to and from the workshop, and the workshop staff will be responsible for the student while he is in attendance. Delegates are expected to arrive on Monday afternoon and remain through the final meeting Friday noon.

COST: The cost of attendance is \$50.00 per person. This fee covers registration, room, board, printed materials, staff expenses, insurance, photographs, general facility and equipment cost. A large amount of spending money will not be necessary.

APPLICATION: To make application, fill out the tear-out form provided in this folder and mail it together with a check for the full amount to the workshop director in the special envelope also found in the folder. DEADLINE for application is June 26. No refunds will be given after July 1. In case of cancellation after July 1, the school is responsible for providing alternates.
